A Public Hearing with Planning Commission is tentatively scheduled for April 15, 2021, which will be followed City Council review and adoption after a public hearing by June 15, 2021.

The Housing Action Plan (HAP) will result in a prioritized list of housing strategies that will be implemented over the next several years. Strategies may include future Comprehensive Plan amendments, changes to zoning or permit processing regulations, or programs.

The City intends to use the HAP as background research and analysis for future amendments to the City of Mukilteo Comprehensive Plan and development regulations.

No additional environmental information has been prepared in relation to this proposal.

Not applicable; this is a non-project action. Any existing projects would be vested to the regulations in place at the time of a complete application. Future projects may be impacted if strategies adopted under the HAP are implemented.

The proposed final HAP will be considered by the Mukilteo Planning Commission at a public hearing. The Planning Commission forwards a recommendation to City Council, which is the final decision authority for legislative actions.

Not applicable; this is a non-project action. There are shoreline and flood hazard areas within the City, generally located along Puget Sound. There are a number of streams that flow through the flood hazard area into Puget Sound, including Big Gulch Creek, Brewery Creek, Goat Trail Creek, Japanese Gulch Creek, Lower Chennault Beach Creek, Naketa Beach Creek, Olympic View Creek, Smuggler's Gulch Creek, Upper Chennault Beach Creek, and a number of unnamed creeks and wetlands.

Not applicable; this is a non-project action. Project actions will be required to comply with any applicable regulations.
