5. Additional plan review required by changes, additions or revisions to plans (minimum chg. 1 hr.)..... \$65.00 per hour*
6. For use of outside consultants for plan checking and inspections or both which includes administrative overhead costsActual Costs

- 5. Additional plan review required by changes, additions or revisions to approved plans (minimum charge – one-half hour).....\$65.00/hour*

Other Inspections and fees

- 1. Inspections outside of normal business hours, per hour (minimum charge ½ hour).....\$65.00/hour*
- 2. Re-inspection fees assessed under provision of Section 116.7 of the UMC, per inspection..\$65.00/hour*
- 3. Inspections for which no fee is specifically indicated, per hour (minimum charge – ½ hr)..\$65.00/hour*
- 4. Plan review fees are 25% of the permit fee.
- 5. Additional plan review required by changes, additions or revisions to plans or to plans for which an initial review has been completed, per hour (minimum charge – ½ hour).....\$65.00/hour*

*Or the total hourly cost to the jurisdiction, whichever is greater. This cost shall include supervision, overhead, equipment, hourly wages and fringe benefits of the employees involved
