# **Meeting Notes**

### **Meeting Objectives:**

**1.) WSF Ferry Terminal Relocation Project Update** - *Charlie and Brian from WSF and Barbara from WSDOT provided the committee a brief update on the WSF Multimodal Facility project. Barbara reviewed a list of possible improvement concepts for SR525. It was noted by staff that this list are all concepts and that one or any combination of them could be incorporated. Feedback by the committee included:*

- a. *Bundling signage improvements (Projects 1, 2, 6, 8) into one larger "Signage Improvements" concept.*
- b. *Eliminate traditional rumble strips from Project 5. However there could still be shoulder enhancements for bikes & peds.*
- c. *Eliminate Project 9 (Switch of Ferry & Local Lanes) from further consideration.*
- d. *At SR525 & 5<sup>th</sup> Street Intersection eliminate Project 3 – Alternative 2 from further considerations.*

**2.) SR 525 Pedestrian Access Project Update** – *Planning & Community Development Director Love presented the Committee two draft pedestrian bridge "Visions". These visions and concept-level cost estimates were prepared by the City's consultants HW Lochner & JA Brennan based on theme ideas from the Parks & Arts Commission (PAC). The next step will be to review the cost estimates with WSDOT to understand where the large difference in costs may be between WSDOT's estimate and*

*the City's estimate. These visions will also be presented to PAC for their input and feedback.*

*CM Champion left after item #2.*

**3.) BTW Plan update** – *Assistant Planner Almgren presented an update to the committee on the current status and schedule of the Bike Transit Walk (BTW) plan. He reviewed the draft “Priority Matrix” for the plan that was workshopped through the Planning Commission in September.*

**4.) Fire Station 24 Generator Replacement Update** – *Topic was deferred to next meeting due to time constraints.*
