PROPOSAL NAME: Medical Cannabis Collective Garden Sunset Code Amendment Ordinance (CA-2016-001)

DESCRIPTION OF PROPOSAL:

To establish a sunset date for the two existing medical cannabis collective gardens located in the city by amending Mukilteo Municipal Code (MMC) as follows:

- Delete the “medical cannabis collective garden” definition from MMC 17.08
- Delete the use “medical cannabis collective garden” from the permitted use table in MMC 17.16.040A
- Delete the permitted use matrix reference note at MMC 16.040(B)(60)
- Amend the permitted use matrix reference note at MMC 16.040(B)(66) to remove references to medical cannabis collective gardens
- Amend Chapter 17.68 MMC, Nonconforming lots, structures, and uses to add a new section, MMC 17.68.080, Medical Cannabis Collective Gardens; and
- Repeal Chapter 5.70 MMC, Medical Cannabis Collective Garden Safety License

LOCATION OF PROPOSAL: Citywide
