**RULES:**

1. A maximum of two passes will be issued per dwelling unit.
2. A maximum of two vehicles per pass, registered and licensed with a licensed gross weight of less than 5 tons owned and under the legal control of the resident, may share the parking pass.
3. Pass holders must write, in permanent ink, at least one license plate number on each pass.
4. The pass allows a vehicle to park in a space in the Downtown Parking District and Lighthouse Park without paying the parking fee.
5. Possession of a pass does not guarantee a parking space will be available to the pass holder.
6. Parking pass is invalid if:
  - a. No license plate number is written on the pass.
  - b. Non-permanent ink is used to write the license plate number on the pass.
  - c. The writing of the license plate numbers on the pass has been altered in any way (e.g. numbers crossed out or written over; or the area covered to allow new numbers to be written)
7. The pass is not valid for overnight parking.
8. The pass is not valid for Boat Launch Parking.
9. The pass is not valid for parking in Boat Launch Parking spaces.
10. If a pass holder wants to change the vehicles listed on the pass (e.g. when a new vehicle is purchased) they may return the pass to City Hall for a replacement, free of charge.
11. If a pass is lost, pass holders must come to Mukilteo City Hall to obtain a replacement pass, free of charge.
12. It is unlawful to: (Ordinance 1365)
  - a. Make any false or misleading statement in the application for a pass.
  - b. Transfer the pass to another person or vehicle.
  - c. Fraudulently alter or create a pass in any respect whatsoever.
  - d. Violate any terms or conditions under which the pass was issued.
  - e. Use or place the pass on any vehicle other than that for which the pass is issued.
  - f. Rent or sell a parking pass.
13. Violation of the terms and conditions of the pass will result in the pass being revoked.
14. City reserves the right to change or discontinue the program at any time.
15. Pass must be displayed on the rearview mirror or on the dash on the driver's side and clearly visible through the windshield of the vehicle.
