RE: Mukilteo School District No. 6 Mukilteo Elementary School Replacement Phase 1, Conditional Use Permit

Dear Mr. Edghill,

Brent Planning Solutions is the permitting/environmental consultant for the Mukilteo School District (District) for their proposed Mukilteo Elementary School (MES) Replacement Phase 1 project. Mukilteo Elementary School, 2600 Mukilteo Speedway, is located directly to the north of Olympic View Middle School. The District is requesting approval for a Conditional Use Permit (CUP) and future building/public works permits for this first phase of the replacement of MES as part the Mukilteo School District 2020 voter approved Capital Bond Expansion Projects.

MES was built in 1982 with permanent square footage of 41,727 and ten portable classrooms to accommodate a current enrollment of 520 students. This construction project will be the first of a multi-phased construction project to fully replace the existing elementary school. The first phase of construction will relocate ten existing classrooms into a new building. The existing vacated classroom space will no longer be used for student teaching space resulting in no increase in staff or student capacity to the site. The proposed Phase I expansion would be approximately 19,973 square feet.

Approval of the CUP, Grading, Drainage, Stormwater Review/Public Works Approval, Commercial Building Permits and Right-of-Way Permits are required from the City. The District will be acting as the lead agency for the environmental review process. The complete CUP application package has been reviewed and is submitted with some reports in hard copy and the rest of the items electronically in accordance with City requirements and discussions.
