
Response to Exhibit 60 Retaining Wall Example - Huntings Hilltop

Findings:


- 1. Maximum Wall Height: 13'

- 5. For road construction.

Conclusion:

Not comparable to Harbor Grove. Walls do not impact adjacent properties outside of plat.



Response to Exhibit 62 Retaining Wall Example – Mukilteo Highlands




Findings:

- 1. Maximum Wall Height: 6'
- 2. Wall Location: Rear perimeter lot line.
- 3. Abuts neighboring properties.
- Accessible for maintenance: Yes (but no drainage or landscaping)
- 5. Meets zoning requirements in MMC 17.20.

Conclusion:

Not comparable to Harbor Grove walls. Impacts on neighboring properties significantly reduced compared to Harbor Grove (low height, no stormwater pump).

Response to Exhibit 63 Retaining Wall Example – Highland Terrace




Findings:
