

AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT BETWEEN
CITY OF MUKILTEO AND THE ALDERWOOD WATER & WASTEWATER DISTRICT
CONCERNING UTILITY CONSTRUCTION ASSOCIATED WITH THE HARBOUR
REACH CORRIDOR ROAD PROJECT

This *Amendment No. 1 to the Interlocal Agreement Between the City of Mukilteo and the Alderwood Water & Wastewater District Concerning Utility Construction Associated With the Harbour Reach Corridor Project* dated February 7, 2018, (the "Original Agreement") is made and entered into by and between the City of Mukilteo ("City"), a political subdivision of the State of Washington, and the Alderwood Water & Wastewater District ("District"), a municipal corporation of the State of Washington.

WHEREAS, the description and estimated cost of the Utility Work as shown in Exhibit C of the Original Agreement were based on estimates compiled by the District at 60% design and prior to sending the Project and Utility Work out for bid; and

WHEREAS, the City advertised and requested bids for the construction of the Project and Utility Work; and

WHEREAS, the City and the District have accepted a bid for the construction of the Project and Utility Work; and

WHEREAS, the description and cost of the Utility Work in the accepted bid is different than the description and estimated costs shown in Exhibit C of the Original Agreement; and

WHEREAS, the parties wish to amend Exhibit C pursuant to Sections XI, in order to reflect the description and costs of the Utility Work included in the accepted bid.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, it is agreed that the Original Agreement shall be amended as follows:

1. Exhibit C to the Agreement is hereby deleted and replaced by Exhibit C-1, attached hereto and incorporated herein by this reference, based on the accepted bid for the Project and Utility Work.
2. Except as amended or modified by this Amendment No. 1, all other terms of the Original Agreement shall remain in full force and effect.
3. The effective date of this Amendment No. 1 shall be as of the last date signed below.

DESCRIPTION AND COST OF UTILITY WORK (District ref# W1703)

Extending approximately 1500 feet of 8-inch water main and associated appurtenance within Harbour Reach Drive. Relocate 16-inch water main at the proposed Picnic Point Creek culvert structure. Replace a sanitary sewer manhole at the proposed Picnic Point Creek culvert structure. Adjust valve boxes and manhole lids to grade.
