All food trucks operating in the City of Mukilteo must\*:

- Have a valid City of Mukilteo business license
- Move locations at least every 72 hours
- Limit hours to between 7am and 10pm (9am to 10pm on weekends if using generator)
- Have the explicit written permission of the property owner where they are operating
- Have an approved [right-of-way permit](#) if operating in the street or on the sidewalk
- Limit signage to the vehicle and one portable sign eight square feet or smaller
- Be in a location that does not interfere with circulation or required parking
- Comply with the city's noise ordinances

Food trucks operating in Lighthouse Park, a public street, or residential zone require review and approval by the city. Food trucks on private property in commercial and industrial zones do not require City of Mukilteo pre-approval but must follow all applicable rules.

### Submittal requirements for food trucks in Lighthouse Park or residential areas:

2. ☐ **City of Mukilteo Business License**
3. ☐ **Explicit written permission of the property owner in residential zones**
4. ☐ **Health Department Approval**

### Additional submittal items for food trucks in Lighthouse Park/on City property:

5. ☐ **Supplemental Information Form (see page 3)**
6. ☐ **Certificate of Comprehensive General Liability Insurance (COI)** with additional endorsement page CG 20 26 listing the City of Mukilteo as additional insured. Minimum coverage \$1 million.
7. ☐ **Background Check** results for business owner and all employees

- Concessions may only operate between the hours of 8:00 am and 9:00 pm.
- Vendors may not enter the park prior to 6:00 a.m.
- Mobile units must be removed at the end of each business day, no later than 9:45pm
- Vending units cannot exceed a length of 40 feet and a width of eight feet, excluding cab.
- Vendor locations do not have storage or electricity available.
- Public restrooms may not be open at all times.
- Vendors are responsible for hauling garbage, grey water, and all other waste away to an off-site location at the end of each operating day for legal disposal.
- No amplified music is allowed.
- Vendors must pay daily rate (\$25) or monthly rental rates (\$400) and follow city procedures for reserving a spot.
- I am responsible for having at least \$1M in Comprehensive General Liability Insurance with additional endorsement page CG 20 26 listing the City of Mukilteo as additional insured.
