Fire watch must be systematic and continuous throughout the facility

Fire watch log must be recorded on the reverse of this form; may use additional paper

Fire watch order and logs must be returned to AHJ after fire watch is completed

Fire watch order must remain posted at main entry or as directed by AHJ

RESPONSIBILITIES

Constant patrols

Notify occupants of system impairment & fire watch

Contact fire protection company for immediate repair

Dial 911 immediately upon recognition of fire or other hazard

Assist occupants in safely exiting structure

Watch for and remove obstructions to the means of egress

Watch for fires and other hazards or emergencies; report to 911

Activate fire alarm system in the event of emergency

Have fire extinguishing equipment; extinguish all fires
