## **SUMMARY/BACKGROUND**

The Board had discussed a goal for the year was to revisit the City's Register of Historic Places program and try to encourage additional applicants. Staff first wanted to give a brief overview of the program as it is described in code and then give an opportunity for the board to discuss activities we can take this year to improve the program.

To list a property on the register, any person (include the board itself) can nominate a building, structure, site, object, or district for inclusion in the register. Once on the list no person shall change the use, construct new buildings or structures, or modify the existing property without review by the commission and receiving a certificate of appropriateness or a waiver in the case of demolition. Decisions of the board can be appealed to the City Council. The board can also remove a property from the register with or without the owner's consent. The existing historic places from the Comprehensive Plan are as follows:
