NEW BUSINESS ITEMS

• July or August PAC Site Visit

Director Price proposed site visits to various locations (Byers Family Park, Waterfront, Lighthouse Park, and Pocket Park) for the upcoming July 1, 2021 Parks and Arts Commission meeting to be held at 6:00 PM – 9:00 PM. The Commissioners were asked to confirm with Director Price if they would be available due to the Fourth of July holiday.

Commissioner Hammerman suggested including the Rosehill board.

OLD BUSINESS ITEMS:

1. Byers Family Park Update

Director Price shared photos of the recent volunteer planting that occurred at Byers Family Park, and thanked all that participated, including Commissioner Field and Councilmember Champion.

Items remaining at Byers Family Park include the power line to be placed underground by Ziply, a commemorative plaque to be installed, and service berry trees to be planted.

The Byers Family Park dedication is scheduled for June 19, 2021 at 1:00 PM.

2. Joint PAC/City Council Meeting Discussion

The Commissioners discussed items with the Council, and Director Price summarized the list. Parks endowment, Lighthouse bed and breakfast, Mukilteo a destination and not a pass through, build up the Art Funding, signage/gateways.

Director Price indicated, per the State, there is a recreation agreement that the City cannot use recreation items for a profit.

Commissioner Hammerman suggested creating an endowment fund to utilize the park. Director Price will look into that idea, and report back to the Commissioners.

Commissioner Foster suggested engaging the Historical Society before discussing with City Council. Director Price will follow up with the Historical Society before the July 1, 2021 site tour.

3. Japanese Gulch Jump Bike Dirt Course

Director Price will be following up with Olympia and the City of Everett, and will report back at the July 1, 2021 meeting.

REPORTS AND COMMUNICATIONS:

Director Price announced the Lighthouse Festival staff will be meeting in the next two weeks to begin planning for the event. To date, there will be fireworks on Saturday evening, a 5K and 10K Muk run on Sunday, and the parade will be returning.

Director Price announced the half time furloughed staff at Rosehill will be returning to work full time.

Rosehill will begin displaying art in the building in the near future.

Director Price shared we may be returning to in person meetings in September of this year.
