- 1. Director Trofimczuk addressed Nominations and elections for Chair and Vice Chair for 2023. Motion to re-elect Chairperson Foster and Vice-Chairperson Ellis to current positions for 2023 year passed unanimously 5-0.
- 2. Motion to move meeting start time to 6:00 pm, passed unanimously 5-0.
- 3. - 1. Congratulations on re-appointments of Chairperson and Vice-Chairperson for 2023. The Commission recognizes Commissioner Zaman's commitment to education, Commissioner Ellis' contribution to the Stormwater Team, and Commissioners Foster and Ellis' volunteer work.
- 2. Director Trofimczuk introduced Mr. George Barron, retired engineer, and master scuba trainer. Mr. Barron provided an overview of Scuba Park and concerns with safety to the public and recommended posting a "No Boat Launch" sign on the stair entrance of the Scuba Park. The Commission agreed to address Scuba Park concerns at the next meeting.
