Removal of Entry Police Officer from Eligibility List Certified on 3/27/2014 Police Officer Candidate Christopher Hayter requested removal from the eligibility list for personal reasons.</p> <p><u>Motion:</u> To remove Christopher Hayter from the Entry Police Officer Eligibility List certified on 3/27/2014. <u>Motion by:</u> Throckmorton <u>Seconded by:</u> Bohnet <u>Action:</u> PASS 2-0 <u>Vote:</u> Unanimous</p> <p>2. Decertification of Entry Police Officer Eligibility List Certified 3/27/2014 Civil Service Secretary/Chief Examiner Passovoy inadvertently erred when applying Veteran's Preference Criteria when scoring applicants for this eligibility list.
