Meeting Minutes:

CALL TO ORDER:

Chair Linda Grafer called the meeting to order at 2:00pm. The group introduced themselves and the three new non-profit members were welcomed.

BUSINESS ITEMS:

- 1. a 2015 LTAC Status Report and Update (Attachment 1) Policy Analyst Liias presented the 2015 LTAC Status Report and Update, which included:
 - Review of the 2014 LTAC Recommendations
 - Three-year Hotel/Motel Lodging Tax Fund financials
 - City projects year-end revenue into the fund of \$243,500
 - 2016 Budget Projections
 - Estimated 2016 revenue: \$251,250
 - Minimum reserve requirement: \$115,000
 - 2016 Grant Funding Level Decisions
 - City estimates that LTAC can award up to \$300,250 in LT grants for 2016, leaving a fund balance of \$140,692
- 2. Executive Assistant Passovoy presented two spreadsheets to the Committee
 - Historical perspective of grant applications; some 2016 applicants have applied in previous years and their grant history presented.
 - Score sheet.

- Chair Grafer asked the Committee for their input on the 8 presentation classifications on the score sheet.
- Chair Grafer asked committee members to use the score sheets and Policy analyst Liias offered to tally the scores for presentation deliberations.
- The committee agreed to make a motion and vote on the proposal to accurately capture the decisions at the end of the meeting.
