Marsha Tolon of the Washington State Department of Transportation Ferries Division on the behalf of the Port of Everett applied for a Binding Site Plan Revision with the City of Mukilteo on November 9, 2016. **Description of Proposal:** Revision of the Binding Site Plan recorded on March 27, 2015 under recording number 201503275003 to reflect the needs of the property owner.

**Location of Proposal:** The project site is approximately 1,800 feet east of the existing terminal in Downtown Mukilteo on the former USAF Fuel Supply Facility commonly referred to as the Mukilteo Tank Farm. See the submitted applications for the complete legal description of the property.


### **Appeals**


