Dear Mayor Gregerson, Mukilteo City Council Members and Citizens of Mukilteo,

2013 was another year of transition that saw major and minor changes around the department. Below is a partial list of some of the highlights of our Public Safety efforts.

Grants brought over \$20,000 worth of equipment and additional overtime coverage for traffic safety projects such as Target Zero Teams DUI emphasis. Continued partnerships with regional agencies have enhanced training opportunities for area police officers and administrative staff. All employees met their mandated training hours again in 2013 with some venturing into new areas such as collision investigation, motorcycle operator and crime scene investigation.

2013 staffing changes included the loss of five staff members, three through retirement and two others who left policing. We were fortunate to hire and train four replacement officers. These officers brought a great deal of energy to an already active, community oriented agency staff. The hiring and staffing of a half-time Department Assistant in the Support Services group greatly increased the level of assistance available at the front lobby window and freed Technicians for other important work.

Internally we have promoted a new Sergeant and Corporal for the first time in nearly five years along with new members in key positions such as Crime Prevention and Administrative Coordinator and motorcycle operator.

A combined work team of department staff performed the Department's first comprehensive Mission and Values statement overhaul in nearly 20 years. The department mission to "provide professional police service for and with the community" and core values of Professionalism, Integrity and Community may be found on our homepage with further detail. Examples of our commitment to partnerships with the community continue include internships with a local community college, school safety presentations with Mukilteo School District and presentation of Citizens Academy and National Night Out events. We can now boast a Volunteers In Police Service (VIPS) team of 19 members!



Sadly, in December the building suffered a significant flood from a burst pipe in our Support Services staff and lobby areas. The resulting damage forced relocation of major operations and reconstructions lasting well into 2014. Staff rallied quickly to overcome the initial issue and were up and running within 48 hours including moving records, evidence processing, fingerprinting and four staff member work stations.

The Mukilteo Police Department staff remains dedicated and enthusiastic looking forward to bringing new members aboard as 2014 progresses.

ADMINISTRATIVE DIVISION

Accomplishments within the Administrative Division during 2013 include:

- A large amount of time, resources and effort were applied towards recruitment, testing, and hiring employees to fill five vacancies on the department. We were able to hire two entry level applicants, one exceptional entry, and one lateral officer. Entry level applicants have no law enforcement experience and must attend the seventeen week Washington State Criminal Justice Training Commission Basic Law Enforcement Academy (BLEA) followed by a three month formal field training officer (FTO) process before they can operate as a solo officer. Exceptional entry hires have completed the BLEA, but have less than two years of experience as a police officer. Before they may operate as a solo officer they must complete our formal three month FTO program. Lateral Officers have completed the BLEA, and have more than two years of law enforcement experience. After being hired lateral officers must complete a two month formal FTO program before operating as solo officers. The process from initial application until operating as a solo officer takes from three months for lateral officers to ten months for entry level applicants. The hiring process is overseen by the Commander with assistance from the Crime Prevention Officer who focuses on recruitment and testing, as well as the Detective Sergeant who conducts the background investigation.
- Many outreach efforts to the community outlined elsewhere in this annual report.
- Close monitoring and administration of the department budget once again resulted in spending under projections.

GOALS AND OBJECTIVES

The 2013 Police Department goals and objectives for each division as well as our progress in attaining them are outlined in attachment ^{A-2}.

PATROL DIVISION

The biggest obstacle faced by the Patrol Division in 2013 was staffing. Although the authorized staffing for the division was twenty commissioned Police Officers at times the Patrol Division was down four people. During 2013 five officers departed the department leaving many of the shifts below our minimum staffing



of three police officers working the road. We filled openings on the road by bringing off duty officers in on overtime. Running shifts with minimum staffing reduces the unobligated time for patrol officers to work on traffic enforcement or other proactive activities. The practice also increases the stress on and exhaustion of the patrol officers.

Activity measures include calls-for-service, traffic enforcement and crime. The total calls for service handled by the Police Department in 2013 decreased from 2012. Those numbers were 10, 958 and 12, 866 calls respectively, which is almost a 15% decrease. A chart of all dispatched calls from 2011 through 2013 is attached as ^{A-3}.

TRAFFIC

Traffic enforcement highlights for 2013

- Completed 254 hours of traffic related training department wide including one officer completing Motorcycle Officer and another completing Advanced Collision Investigation.
- We continued our partnership with the "Target Zero Teams DUI/Traffic Task Force" in order to address traffic safety not just within Mukilteo, but the entire county as well.
- The department added two more portable breath test (PBT) devices to our inventory through a grant received from the Washington State Traffic Safety Commission.
- For the third consecutive year we had no fatal traffic collisions in Mukilteo. There were three fatal collisions in 2007, and one in each of 2008, 2009, and 2010.

SPECIAL OPERATIONS DIVISION

In February detectives spent numerous hours following up on a male that had stolen the identity of two residents, charging thousands of dollars to credit accounts. The subject had a record of the same crime where he had served jail time. He was arrested, prosecuted, convicted, and sentenced on the crimes in Mukilteo, several in Everett, and some in Colorado.

In March Detective's investigating a string of residential burglaries developed a suspect. The suspect eventually confessed and his statements led Detective's to the recovery of a large amount of stolen property and were able to solve thirteen residential burglary cases.



Also in March Detective's obtained and served a search warrant on a room in a local motel after developing probable cause to believe the room was being used to produce false identification. Detectives found numerous fake drivers licenses, stolen mail, and thousands of dollars' worth of fraudulently purchased phones, computers and other electronic items. Four suspects were arrested. After going through all of the items seized Detectives were able to solve over 100 cases of fraud and identity theft.

In December Detectives assisted with the trial of a suspect who had been charged with criminal mistreatment for the starvation of his adopted sister who lived the male and his girlfriend. The male was found guilty and was sentenced to 12½ years in prison.

COMMUNITY SERVICE OFFICER

The Community Service Officer has three major areas of responsibility.

①Animal Control, ②Parking Enforcement, and to ③Assist in Support Services.

The Community Service Officer is a partially commissioned position reporting to the Commander.

The Community Service Officer, Shanita Duke, was recognized in front of the Mukilteo City Council with a "Lifesaving Award" acknowledging her actions on September 1, 2013 when she performed CPR on dog who was dying.

ANIMAL CONTROL

The City of Mukilteo contracts with the Progressive Animal Welfare Society (PAWS) to provide sheltering services. The shelter statistics from PAWS showed an increase in the number of animals taken into their facility from our city. In total 104 different cats (54) and dogs (50) were brought into the shelter either by the Community Service Officer, or by residents of Mukilteo.

SUPPORT SERVICES DIVISION

In 2013 Support Services continued its maintenance program for the front office by completing the records destruction of old files through Datasite Shredding. Support Services also completed another large property auction through PropertyRoom.com. Research has begun on bar coding systems that will bring the evidence room on line from a paper logging system in 2014.

There was a slight increase in case reports handled. The division processed \$345,348 in fines and bail forfeiture during 2013

In December a fire suppression system failure related to freezing weather caused significant water damage to the records and evidence areas of the police department. The damage forced us to relocate our Support Services Division into the Emergency Operations Center until repairs can be completed. A timeline for completion of repairs has not been developed as of the time of this reports writing.

A Support Services Activity Comparison Report is attached as ^{A-4}.

A worksheet detailing a three year comparison of Citations, Infractions and Jail Bookings is also attached ^{A-5}.

TRAINING

Training hours for department members increased dramatically from 2012 to 2013. We had an almost 65% increase in total training hours. The 4,269 hours of training we received were for the most part due to putting three newly hired officers through the seven hundred and twenty hour long Washington State Criminal Justice Basic Law Enforcement Training Academy. Not included in these training hours are the twelve weeks spent in field training for the three newly hired officers. A lateral officer we hired in 2013 went through eight weeks of field training as well. Highlights of 2013 training include having an instructor recertified by the Washington State Criminal Justice Commission as a Master Instructor in Defensive Tactics. We also had a traffic officer complete Advanced Collision Investigation and another traffic officer complete Basic Police Motorcycle Training.

The department again conducted two range qualification/trainings in 2013, conducted department wide Active Shooter training with the SNOCOM dispatch center, trained all officers on use of the ballistic shield, and incorporated



defensive tactics into the training. One of our firearms instructors also trained the Mukilteo Fire Department personnel on Rapid Responder/Staging/Active Shooter response.

The police department 2013 year-end Employee Training Hours Report is attached as ^{A-6}.

CRIME PREVENTION DIVISION

In mid-September Officer Colt Davis moved from the Patrol Division into the Crime Prevention Division. He took over the full duties as our Crime Prevention Officer on October 1, 2013. The former Crime Prevention Officer, Cheol Kang, moved back to the Patrol Division after being promoted to Sergeant.

CITIZENS ACADEMY

The purpose of the Mukilteo Police Citizens Academy is to provide the citizens and business community with a better understanding of the day-to-day operations of the Police Department. The eight week course provided information about the various divisions in the Department in addition to criminal law & procedures, officer safety, police equipment, hiring and recruiting, and investigations. Students are also provided with the opportunity to ride along with a patrol officer for part of a shift.

In 2013, the Department hosted one class (Sept 5 – Oct 24), with 13 students graduating. Total cost was \$1166.44 (\$213.52 for food/refreshments, and \$952.92 in overtime costs for the instructors).

NATIONAL NIGHT OUT AGAINST CRIME

National Night Out is a program which partners local law enforcement agencies with their communities in an effort to heighten crime and drug prevention awareness while generating support for local anticrime efforts.

We continued our partnership with local business and community groups to create a very successful event with over 1,000 people attending. Planning for this event began in January continuing until the event date in August.

NEIGHBORHOOD BLOCK WATCH

The Neighborhood Block Watch program is a partnership between residents and law enforcement to improve safety and prevent crime. Neighborhoods are encouraged to gain some familiarity with each other and to understand what



constitutes reportable suspicious activity. Active Block Watch groups not only serve as the eyes and ears of the police department, but they also are able to identify and correct potential "crime hazards." Crime hazards are unsafe conditions and specific locations that can possibly harbor criminal activity. Neighborhoods that decide to form formal Block Watch groups are visited by the Crime Prevention Officer who presents program information and establishes liaisons (Block Captains) for the neighborhood. Pertinent crime bulletins and quarterly burglary reports are distributed to Block Watch Captains. Block Watch signs are posted in neighborhoods and decals are provided for homeowners.

In 2013 we expanded to forty-two neighborhood block watch groups from thirty-nine groups in 2012. The costs associated with the Block Watch program have been minimal, requiring only the printing of brochures and the purchase of window decals and street signs. One street sign is provided by the Police Department and additional signs are at the expense of the block watch group.

Several success stories have been printed in the Mukilteo Beacon and Everett Herald where active block watch groups reported suspicious activity, and ultimately aided the police department in apprehending burglars.

CRIME PREVENTION THROUGH ENVIRONMENTAL DESIGN (CPTED) SURVEYS

The Crime Prevention Division offers free CPTED security surveys for Mukilteo businesses and homeowners. This survey details current security programs and provides recommendations with regard to their physical security situation and environmental considerations such as lighting, landscaping, space management, etc. Twelve CPTED surveys were conducted this year for businesses, homeowners, and various areas in the City. Eight surveys were conducted in 2012.

CRIME TREND ANALYSIS

All Burglaries, Vehicle Thefts and Vehicle Prowls are tracked to establish and determine crime trends. Each quarter, a burglary report and burglary map is generated and is distributed to the Special Operations Division. Information is shared with the Patrol Division for increased patrols. Informational bulletins were distributed to the Block Watch Captains and the Mukilteo Beacon when a crime trend was noted.



FALSE ALARM REDUCTION PROGRAM

Residential and business alarm systems are great deterrents and tools available to lessen the likelihood of becoming the victim of a burglary. An unfortunate byproduct of alarm systems are “false alarms” that police are frequently dispatched to.

The overall goal of this program is to identify repeat false alarm offenders and provide the appropriate education and training necessary to eliminate future false alarm events. The overall success of this program ensures the adequate availability of police officers for valid emergency events.

Businesses and residences that have two false alarm responses within a six month period receive a warning letter from the Crime Prevention Officer which states they are in violation of the Municipal Code and to coordinate corrective efforts with their alarm company and the Crime Prevention Officer. Nine warning notices were sent to homeowners and businesses throughout the City. Offenders with three or more false alarm responses within a 6 month period are issued a Notice of Infraction. One infraction was issued in 2013. Although the number of false alarms increased in 2013 the number of warning letters decreased. There were numerous single false alarms at residences. A comparison of false alarm data from 2011 – 2013 is depicted in the following chart.

VOLUNTEERS IN PUBLIC SAFETY

The Volunteers in Public Safety (VIPS) program provides the Department with the use of volunteers who have particular skills, desires and experience while encouraging police-citizen partnerships consistent with the values and goals of our community policing philosophy.

In 2013 we added seven new members to the VIPS program. Each volunteer is screened and receives training comprised of administrative indoctrination, policy & procedures, radio use, radar reader board training, and vacation house checks. All volunteers are recruited from the Citizens Academy classes. The



volunteers also assisted with Active Shooter Training this year as well as helping organize the Police Department.

The following chart shows the number of hours of work our volunteers provided the City from 2011 – 2013.

COMMUNITY OUTREACH

Requests for general and specific topic presentations have been fairly consistent from business, community and residential groups. A total of thirty separate presentations were provided by the Crime Prevention Officer in 2013. Topics ranged from drugs and alcohol, general safety, home protection, and police facility tours.

The Mukilteo Police Department has continued to maintain our relationship with the safety forum/discussion group created by the administrators for the public schools inside the City of Mukilteo. Topics of discussion have focused on school lockdowns, disaster preparedness, and student safety.

The Police Department is continuing its partnership with the Mukilteo School District's Drug & Alcohol forum which establishes prevention programs and presentations for parents and students. The Crime Prevention Officer serves on the Advisory Council for the Mukilteo School District's Career and Technical Education program and as an advisory board member for the Snohomish County Business Watch. The mission of the Snohomish County Business Watch is similar to a neighborhood block watch with businesses sharing pertinent crime prevention tips and information. The group has grown and is looking at expanding to include more business groups from the north part of Snohomish County.

PUBLIC INFORMATION OFFICER

The Crime Prevention Officer serves as the Department's Public Information Officer. In addition to distributing an official daily activity "press log" the Crime Prevention Officer issued thirteen press releases and media updates covering major incidents and noteworthy events.



The Crime Prevention Officer has also taken on a “webmaster” role for the Police Department’s homepage on the City of Mukilteo website. Numerous updates have been made to the format and content for the Department page to improve every citizen’s ability to answer many of their questions and concerns, and obtaining additional information about their police department.

RECRUITING

Six oral boards were completed in 2013 for entry level and lateral police officers. We hired two new entry level Officers, one exceptional entry, and one lateral Officer in 2013.

SPECIAL PROJECTS

Department Historian: The VIPS volunteers have taken on the task of compiling the Department’s history and timeline. They are working with the Mukilteo Historical Society and Mukilteo Beacon newspaper for this project. The project has been a slow process as there has not been much information located prior to the 1990s.

Shop with a Cop: The Shop with a Cop program teams up children, who need extra assistance during the holidays, from the area with a law enforcement officer to go shopping for Christmas gifts. Thanks to numerous donations from the community to include, not limited to: Travis Industries, The Mukilteo Police and Fire Associations, Papa Murphy’s, Extreme Stream Carpet Cleaning, and Fred Meyer, the Mukilteo Police Department hosted its own event Dec 19th. Our Department teamed up with firefighters from the Mukilteo Fire Department, the Snohomish County Sheriff’s Office, SNOCOM, and Mukilteo Police Department Support Services to take twenty children Christmas shopping.

Run from the Cops: The Run from the Cops 5K Fun Run is a fundraising effort organized by law enforcement agencies throughout the state benefiting Special Olympics Washington. The Mukilteo Police Department organized their first Run from the Cops 5K Fun Run on September 13th 2013.

Women’s Self Defense Seminar: The Mukilteo Police Department sponsored a women’s self-defense seminar on December 14th 2013 at the Rosehill Community Center. The course was offered to provide women and teens with information on personal safety, with an emphasis on self-defense techniques. The course was instructed by instructors from Charlie’s Combat Club in Everett.



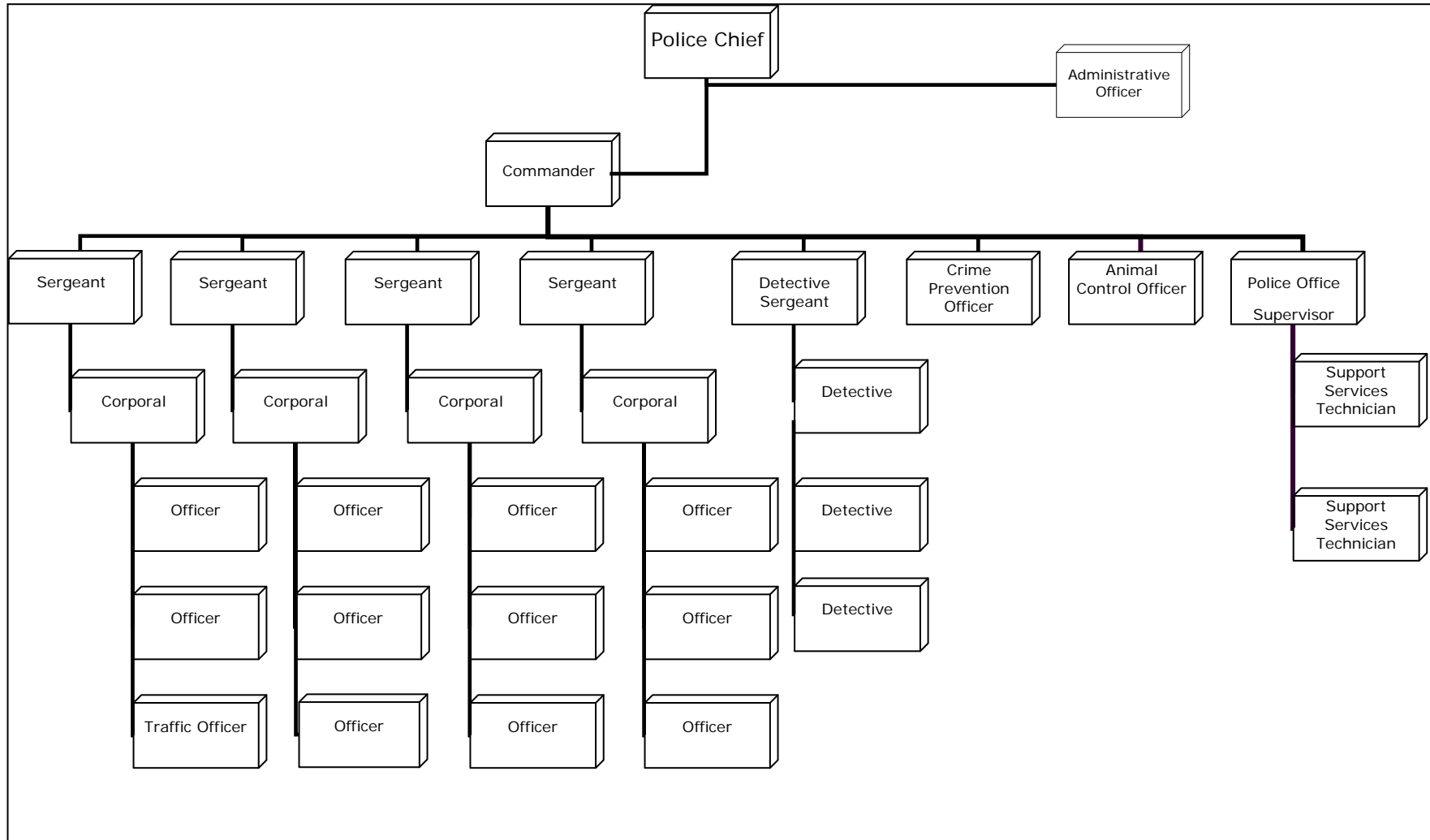
The Crime Prevention Officer worked with the Snohomish County Sheriff's Officer to present information on victimology and a "combat mindset."
