Annual Pavement Preservation Program



Thank you in advance for your patience and cooperation as we make improvements to your neighborhood.

What: As part of our annual Pavement Preservation Program, the City of Mukilteo is pleased to announce that the contractor, Central Paving, LLC, will be repairing portions of Lighthouse Park and 2 streets.

Thanks to the Transportation Benefit District voted in by residents in 2017, the City is able to have an annual street preservation program. This preventative maintenance not only prolongs the life of a street but will save money by improving the street surface before it reaches the final state when rapid deterioration occurs, and full reconstruction is required. This year's program focuses on areas where the existing asphalt pavement is severely damaged. In these cases, the damage needs to be removed and replaced, often all the way down to the base.

Where: Areas of Lighthouse Park (#1-5), an alley off of Cornelia Ave. (#6), and a portion of 95th Pl SW (#7). Note that the alley resurfacing will require full closure for most of the day that the work is done. We'll notify residents at least 24 hours before the closure with door hangers at each residence and signs on the street.





When: Construction is anticipated to begin in October with anticipated completion by December. Specific schedule information for each street will be posted and updated periodically on the City's website https://mukilteowa.gov/2020-pavement-preservation-program/. It is possible that construction schedules change due to weather conditions. Typical hours of operation are Monday-Friday 7:00 am to 6:00 pm.



What to Expect:

Temporary lane or street closures with signs and flaggers directing traffic Please allow extra time, follow directions, and drive safely in construction zones.

Advanced notice of lane closures and parking restrictions:

During construction: Notices will be distributed or signs will be posted for adjacent residents and businesses within 24 hours prior to paving.

Parking: "No-Parking" signs will be posted 24 hours in advance of all parking restrictions. **The City will tow vehicles left on the street after the 24-hour notice period.** Please do not leave vehicles parked on the street while on vacation.

Driveway access: In some locations, it may be necessary to limit driveway access for a few hours while fresh asphalt is allowed to cool. If your driveway is affected, you will be specifically notified prior to work being performed.

Emergency access: Emergency vehicle access will be maintained throughout the construction process. The contractor is required to backfill and/or cover their work at the end of each day so there will be no open trenches left over night.
