**Conditions of Issuance:**

1. Place boat launch parking permit on dashboard in visible location.
2. Expires December 31, 2020
3. Does not guarantee a parking space.
4. Four (4) consecutive nights maximum.
5. No "trailer-only" parking.
6. Fees not refundable.
7. Valid at Mukilteo Lighthouse Park only.
8. Vehicle(s) must be registered at permit holder's address.
9. For resident discount, proof of residency and vehicle(s) must be registered at holder's Mukilteo address.
10. The City has the right upon reasonable advance notice to the permittee to close the boat launch parking spaces for good cause, including but not limited to maintenance or special events sponsored by the City of Mukilteo, and to immediately close the parking spaces in the event of emergency.

**Hold Harmless/Indemnification Agreement:**

The Applicant/Permittee agrees to defend, indemnify, hold harmless and release the City of Mukilteo, its officials, employees and agents from any damage claim or lawsuit for injury, illness, damage or other loss incurred in connection with use under this permit, except for injuries or damages caused by the sole negligence of the City.

# Boat Launch Parking Permit Information

## Mukilteo Lighthouse Park

### **DAILY PARKING FEES:** (Pay at Site)

	<b><u>May 15 – Sept. 30</u></b>	<b><u>Oct. 1 – May 14</u></b>
Vehicle/Trailer Parking Fee 1 – Day	\$15.00	\$10.00
Vehicle/Trailer Parking Fee 2 – Days	\$30.00	\$20.00
Vehicle/Trailer Parking Fee 3 – Days	\$45.00	\$30.00
Vehicle/Trailer Parking Fee 4 – Days	\$60.00	\$40.00

**Docks are available for use from approximately May 15 – September 30.**

### **ANNUAL FEES:**

Annual permit holders are authorized to park overnight in the vehicle/trailer parking stalls, with the permit displayed, for up to a maximum of four (4) days at any one time.

Annual Permit (Non-Resident)	\$100.00
Annual Permit (Resident)	\$ 50.00

### **ELIGIBILITY REQUIREMENTS FOR PERMITS:**

(1) Vehicle must be registered at permit holder's address

### **ELIGIBILITY REQUIREMENTS FOR RESIDENT DISCOUNT:**

(1) Proof of residency by:

(a) Display of valid driver's license reflecting current address.

(b) Display of deed, lease, rental agreement, or other acceptable document showing residency.

(2) Vehicle must be registered at permit holder's address.
