- 1. Election of Chair and Co-Chair

  - Commissioner Northfield nominates self for Vice-Chair.
  - Commissioner Northfield motion to approve the nominations, second by Commissioner Ripley.
  - Nominations approved 4-0.
- 2. Hawthorne Hall Update
  - Director Galuska shared an update that Council has voted to sell Hawthorne Hall.
  - Staff reaching out to two entities interested in the building and the land to ask them to provide a bid for the property, what they'd want to use it for and the purchase price and bring that back to council.
  - Any building permits submitted including demolition would need to come before the Historic Commission for approval.

- 3. Neighborhood Boundary Effort
  - Director Galuska shared the idea of potentially moving away from zones in the Comprehensive Plan to something more neighborhood based (Old Town, Mid Town, Goat Trail, Harbour Pointe, etc.).
  - Commissioners discussed current neighborhoods and annexation history.
