RE: AT&T Application for Franchise for Location of Telecommunications Facilities within City Right-of-Way within the City of Mukilteo

To the City of Mukilteo:

On behalf of New Cingular Wireless PCS, LLC ("AT&T") we are pleased to present this application for a new Franchise for Location of Telecommunication Facilities within the City of Mukilteo to address planned small wireless facilities deployments.

AT&T requests that the City grant a city-wide franchise to authorize small wireless facilities in the rights-of-way. Initial build-out is two small wireless facilities with locations that have been determined, with a third small wireless facility location that has yet to be determined, and as such is not included in the attached map. Future build-out numbers of facilities and locations are currently unknown.

Submittal Documents:

In addition to this cover letter, we include the following documents:

- Letter of Authorization for Wireless Policy Group to submit this Franchise Application on behalf of AT&T;
- CONFIDENTIAL AND PROPRIETARY Area map showing currently proposed small wireless facilities in the City;
- Sample detailed schematics of a proposed AT&T wood pole SWF installation reviewed by Snohomish County PUD;
- Illustrative visual renderings of potential SWF designs (the proposed SWF locations do not yet have final designs, but are expected to be on replacement wood utility poles);

- FCC licenses authorizing AT&T to operate; and

A check in the amount of \$5,000 for the Franchise Application Fee Deposit is being sent via Federal Express separately, and a copy of which is enclosed.

Unable to Confirm Business License Status:

According to the Washington State Department of Revenue, New Cingular Wireless PCS, LLC does not currently have the City of Mukilteo or as an added endorsement to its state license. New Cingular Wireless PCS, LLC will obtain the necessary City of Mukilteo business license as an endorsement to its state business license at the appropriate time in the franchise application process.

Below please find narrative responses to the items in the franchise application form:

1. Area Map Showing Location of Proposed Telecommunications Facilities in the City

See attached map of proposed small wireless facilities including GIS locations. AT&T does not currently operate small wireless facilities in the City of Mukilteo.

2. Proposed Locations For New Ducts, Conduits, or Poles

AT&T proposes to locate its small wireless facilities on existing poles, or replacement poles in substantially the same location as existing poles. Locations for ducts and conduits for power and fiber will be managed by third-party power and fiber providers, and are not currently able to be determined by AT&T.

3. Registration in the One-Number Locator Service Not Required

AT&T is not required by law to register in the one-number locator service.

4. Proof of Agency

See attached Letter of Authorization.

5. No Registration with the Washington Utilities and Transportation Commission:

The Washington Utilities and Transportation Commission (WUTC) does not regulate radio communication service (wireless) companies. RCW 80.66.010. As such, New Cingular Wireless PCS, LLC is not registered with the WUTC, and no submittal is required for this item.
