No ground-based facilities are currently proposed, and all currently proposed facilities are expected to be located on existing or replacement poles. Power and fiber will be provided by third parties with existing franchises to operate in the City of Mukilteo.

If the proposed facilities and/or other equipment are proposed to be installed on poles, will the installation be on existing poles or does applicant anticipate the need to install new poles?

Currently proposed facilities are expected to be installed on existing poles, or replace the existing poles with stronger poles to support the facilities (which is often the case). Future SWF may be proposed on new poles on a site-by-site basis.

Note - Applicants seeking to install new poles must follow the procedures outlined in the municipal code. Applicant should not presume that requests to install new poles will be approved.

Describe your site access policies.

AT&T will have 24/7 access to its equipment mounted on poles in the ROW, subject to terms in its agreements with pole owners.

Describe the transmission medium that will be used to provide telecommunications.

Wireless; although small wireless facilities will need to be connected to fiber, provided and owned by another company, to provide wireless service.

 The Internet Tax Freedom Act does not apply to deployment of small cell networks in the City of Mukilteo. The Act applies to prohibit the state and local taxation of certain internet services that AT&T sells, and is not related to placing equipment in the public right-of-way.

 Visual renderings and drawings for similar wood pole installations are provided. Please note that these drawings and renderings are merely illustrative and do not represent the actual design of the facilities currently being proposed in the City of Mukilteo. The schematics are of one potential design reviewed and deemed acceptable by Snohomish County PUD. The photo simulations are of multiple types of AT&T equipment and are rendered to include potential 5G panel antennas. 5G antennas on SWF in the City are not currently proposed, but may be proposed in the future. Each site must be designed on a case-by-case basis, and the designs for the currently proposed nodes have not yet been finalized.

The City of Mukilteo reserves the right to ask additional questions on a case by case basis.
