**Project Information:** This is a proposal by Chris Estes to construct a new 2,134 square foot single-family residence on property located at 6xxx Webster Way (Parcel ID 00408600400300) with associated grading and street frontage improvements. The parcel is approximately 14,220 square feet in size and contains a steep slope. The applicant is proposing a reduction in the minimum required setback of 25 feet from the top of the steep slope to 10 feet, and a reduction in the front setback from 20 feet to 10 feet. These requests require approval from the Hearing Examiner after a public hearing.

The public is invited to submit written comments on the project to the Community Development Department by 4:30 PM on July 16, 2021. Due to COVID-19, staff are unable to accept comments in person until July 6, 2021. City Hall will open for limited hours starting July 7, 2021. Comments must be delivered by mail, personal delivery to the drop box outside City Hall or by email to [rlitter@mukilteowa.gov](mailto:rlitter@mukilteowa.gov), or in person July 7, 2021 or later. City Hall is located at 11930 Cyrus Way, Mukilteo, WA 98275. You may also request a copy of the decision once made and obtain information about appeal rights.

The City will not act on this application until the end of the 14-day public comment period. You may request a copy of the final decision on the project by making a written request to the City contact person named above.
