## PARKING ZONE

- Zone A
  - Permits exempt vehicles from the "No Parking 2:30 - 4:30 AM" and "4-hour Parking" restrictions.
  - Residents may obtain up to two (2) permanent parking permits and one (1) guest permit.
- Zone B
  - Permits exempt vehicles from the "No Parking 2:30 - 4:30 AM" and "4-hour Parking" restrictions.
  - Residents may obtain one (1) permanent parking permit and one (1) guest permit.
- Westridge
  - Permits exempt vehicles for residents whose houses front or access the streets with the "No Parking 8:00 AM – 4:00 PM" restriction.
  - Residents may obtain up to four (4) permanent parking permits plus two (2) guest permits.
- Whidbey Lane
  - Permits exempt vehicles for residents whose houses front on streets with the "No Parking 7:00 AM – 2:00 PM" restriction.
  - Residents may obtain up to four (4) permanent parking permits plus two (2) guest permits.

## ACKNOWLEDGEMENT AND SIGNATURE
