## NOTICE OF APPLICATION SUMMARY

### **2019 Shoreline Master Program Update and Title 17B Shoreline Management Regulations Amendment**

February 4, 2019

The City of Mukilteo is updating its Shoreline Master Program (SMP), in accordance with the State of Washington Shoreline Management Act, and amending Title 17B Shoreline Management Regulations of the Mukilteo Municipal Code. The proposed SMP documents, code amendments and all supporting documents are available at City Hall for public viewing. (File No. CA-2018-003).

Environmental documents prepared for the proposal include: an environmental checklist prepared for the 2019 Shoreline Master Program Update and Title 17B Shoreline Management Regulations; 2015 Comprehensive Plan Environmental Checklist dated April 8, 2015 and Determination of Nonsignificance (DNS) issued April 17, 2015; the Downtown Waterfront Master Plan Environmental Checklist dated May 2015 and DNS issued May 29, 2015; By the Way Plan Environmental Checklist dated October 10, 2016 and DNS issued October 19, 2016; the Japanese Gulch Master Plan Environmental Checklist dated November 2015 and DNS issued December 7, 2015; the Parks Recreation Open Space and Arts Plan Environmental Checklist dated August 29, 2017 and DNS issued September 7, 2017; Anchor Environmental LLC, October 2003, Mukilteo Shoreline Characterization; 2002 City of Mukilteo Shoreline Master Program, Pre-Draft, Appendix C: Watershed Technical Analysis; City of Mukilteo 2011 Shoreline Management Program; ESA Adolphson 2008 Draft Lake Serene Characterization Technical Memorandum

#### **Public Hearing**

The Planning Commission will hold a public hearing on the proposed update and make a recommendation to City Council. That hearing is tentatively scheduled for **April 18, 2019**. The **City Council** will then hold a public hearing and make a final decision to approve or deny the proposals. That hearing is tentatively scheduled to occur in **May/June 2019**.

#### **Department of Ecology Approval**

After the preliminary approval of the SMP by the City Council, the SMP and shoreline regulations will be sent to the Department of Ecology (DOE) for approval. Any edits offered by the DOE will be incorporated into a final SMP that is tentatively scheduled to be adopted by the Mukilteo City Council in the third/fourth quarter of 2019.
