DETERMINATION OF NONSIGNIFICANCE (DNS)

DESCRIPTION OF PROPOSAL Mukilteo Comprehensive Plan Capital Facilities Element amendments as follows:

APPEAL PERIOD: This determination may be appealed as provided for by Mukilteo Municipal Code (MMC) Chapter 17.84. Appeals shall require filling out the appeal form and submitting it with applicable supporting materials and appeal fee, which is non-refundable, to the "City of Mukilteo." Submit the appeal form and fee to the City of Mukilteo City Hall, Community Development Department, at 11930 Cyrus Way, Mukilteo, WA 98275 no later than **4:30 pm on Thursday, September 30, 2021.** At a State Environmental Policy Act (SEPA) hearing, all testimony shall be "under oath". You should be prepared to make specific factual objections. Contact the Community Development Department to read or ask about the procedures for SEPA appeals.


