Please find the attached revised Verizon's Franchise Application, supplemental narrative questions, and Application Deposit Fee.

Narrative

- 1) *An accurate area map showing the location of proposed and existing (if any) telecommunications facilities in the City that the applicant intends to use.*
 - Verizon anticipates approximately 10-15 small cells to be built out in the City in the next few years. In an effort to partner with the City, Verizon would like to execute a Franchise Agreement first and then submit site specific locations to the Public Works Department.
- 2) *The location proposed for new ducts, conduits, or poles, and evidence that there is sufficient capacity within the public ways for the proposed telecommunications facilities.*
 - This information will be provided at the time of site specific small cell permits applications in accordance with the City Municipal Code.
- 3) *Evidence of registration in the one-number locator service, as described in RCW Chapter 19.122.*
 - Verizon Wireless small cell infrastructure is located on above ground poles. Any fiber and/or utility connections that are installed beneath the ground surface will rely on that entity's one-number registration.
- 4) *Proof of agency, if necessary (as indicated above).*

This report should contain detailed information as to how you calculated the utility taxes owed to the City.*
